Genotoxicity:	<i>In vitro</i> : No increased frequency of mutation and no chromosome abnormality were observed (NEDO project, Nakanishi <i>et al.</i> , 2011). <i>In vivo</i> : No formation of micronucleus (NEDO project, Nakanishi <i>et al</i> , 2011).
Carcinogenicity and Teratogenicity	To our knowledge, this product is not considered teratogenic. Possible carcinogenic effect due to the nickel content.

In addition to the toxicological information detailed above, some of the individual ingredients composing the single-wall carbon nanotubes might have toxicological properties.

### Nickel dust and fumes:

Can cause irritation of eyes, skin and respiratory tract.

<u>Chronic overexposures:</u> Can cause perforation of the nasal septum, inflammation of the nasal passages (sinusitis), respiratory sensitization, asthma and scarring of the lungs (pulmonary fibrosis).

<u>Nickel alloys IARC/NTP</u>: Reviewed but not recommended for listing by the NTP. Listed as possibly carcinogenic to humans by IARC (group 2B).
